



## Place your OPS Canteen orders online with Spriggy Schools

Spriggy Schools makes lunch orders convenient for both families and our OPS canteen.

To access your \$3 credit:

1. Go to [www.spriggyschools.com.au](http://www.spriggyschools.com.au) to register and order. Download the app from your App Store if you'd prefer to use your [Apple](#) or [Android Mobile](#)
2. Add a profile for your Kindergarten children, making sure you select **Orange Public School Infants** and your child's class. You can also add in any allergies that are applicable.
3. One \$3 credit will be added to the parent account of each Kindergarten child. Credits will be made at the end of February and at the end of the term.

**If you have already set up Spriggy Schools, your account will be credited with the \$3 at the end of February.**

Please note:

- One \$3 credit per child enrolled in Kindergarten in 2023.
- Parent or Carer must set up account and add in their child before Thursday 6 April 2023 to receive the credit.
